# Governor's Volunteer Service Awards: applications now open!

The Serve Illinois Commission on Volunteerism and Community Service presents the Governor's Volunteer Service Awards. These awards recognize individual volunteers through a statewide award program to highlight the importance of volunteerism and community service in the state of Illinois.

The following awards categories are offered:

- Adult (19-54 years old)
- AmeriCorps Member (member of an Illinois AmeriCorps national service program)
- Business (a for-profit company)
- Senior (55 years old plus)
- AmeriCorps Seniors Members (55 years old plus who are members of the national service programs Foster Grandparent Program (FGP), Retired Senior Volunteer Program (RSVP), Senior Companion Program (SCP))
- Youth (18 years old or younger)
- COVID-19 Medical Volunteer (special recognition for 2021)

A panel of judges from across the state, consisting of governor-appointed commissioners, former awardees, and Illinois leaders, will select the award recipients. 2021 nominations opened on July 1, 2021 and close August 15, 2021.

Nominate an Illinoisan for the highest Illinois statelevel recognition for volunteers. U.S. citizenship is not required for nomination. Illinois state residency is required.

### 2021 Governor's Hometown Award

Young Leaders in Action - Decatur, IL

Young Leaders in Action (YLIA), a youth-led initiative of 108 Macon County high school students wanting to positively benefit their community, is the winner of the 2021 Governor's Hometown Award. Sponsored by The Community Foundation of Macon County and Decatur Rotary Club No. 180, young adults widen their philanthropic view and leadership skills by participating in community service projects, monthly planning meetings, educational workshops, and more.

Examples of the group's outreach include sack-lunch distribution, collecting Christmas gifts for local foster children, an international youth-led conference open to other area high school students, and more.

The other finalists for the 2021 Governor's Cup were The Village of Flossmoor's Martin Luther King, Jr. Day of Service, The Village of Barrington's Dreamway, and Albion's Hope Center. 

## Congratulations to the 2021-2022 AmeriCorps grantees!

Illinois has received \$17,120,066 in funding from AmeriCorps.

These grants will put more than 1,000 AmeriCorps members on the ground to serve with 12 organizations awarded with federal competitive-level funds, tackling some of the toughest problems in Illinois. Serve Illinois, the Governor-appointed commission on volunteerism and community service, will also receive \$5,203,583 in state-determined formula funding, which will, in turn, be awarded to Illinois organizations to support an additional 33 AmeriCorps members in the coming months.

Executive Director

Noelle Ayoka Mota Samuels (known as Ayoka) is the Executive Director for the Serve Illinois Commission on Volunteerism and Community Service and has been in this role since the fall of 2020. In her role, she provides leadership and strategic direction for AmeriCorps programs, strategic volunteer efforts, the Community Emergency Response Teams (CERTS), medical volunteering along with disaster/emergency volunteering throughout the State of Illinois. Before joining the Commission, she served as the Director of the Gary Comer Youth Center in Chicago's Grand Crossing community providing supports and opportunities for more than 4,000 youth and their families annually since 2006.

A native Chicagoan, Mrs. Mota Samuels studied at the University of Illinois at Urbana-Champaign in Agricultural Communications & Education and later received a Master of Non-Profit Management degree from Spertus Institute of Jewish Studies. In addition to her academic accomplishments, Ayoka has served in the nonprofit sector professionally since 1993.

The organizations where she has served include Boys & Girls Clubs of Chicago, Boys and Girls Clubs of America, BR&R Communications, Muntu Dance Theatre of Chicago, New Concept Development Center, and as a consultant for Malcolm X College's Kwanzaa Committee. Additionally, Ayoka has been a contributor to several organizations, initiatives, and coalitions over the years at community, city, national and international levels working to improve the quality of life for Illinois residents and all global citizens. She also provided professional development training for various agencies such as After School Matters, the Chicago Park District, the Illinois Afterschool Network and the Alliance for Strong Families and Communities. She is a member of the Chicago Community Chorus, The Chicago Peace Hub and she's also a founding member of Antonio's Response for Victims of Gun Violence.
