Governor's Hometown Awards Announcement

The Serve Illinois Commission on Volunteerism and Community Service in partnership with the Governor's Office announces the Governor's Hometown Awards (GHTA), has officially opened and is now accepting Letters of intent (LOI), from communities, programs, and local units of government interested in competing for the Governor's Cup. The GHTA gives formal recognition to those who contributed to projects that improved their community's quality of life. Prospective projects, in collaboration with local units of government, should have had strong volunteer support, met a need, and made a definitive impact, thereby generating a positive outcome in the community, and by extension, the state. Only projects completed between January 1, 2021, and December 31, 2021, will be considered.

- 3/10 4/4 LOI must be received by our office email or postmarked on March 4, 2022.
- 4/5 4/11 LOI will be reviewed.
- 4/13 Applicants will receive a notice of decision.
- 4/16 5/13 All applicants moving to the next round will be asked to submit an application and full proposal. All applications must be received by email no later than 5:00 pm or postmarked May 13, 2022.
- 5/14- 6/1 Projects will be reviewed and scored by judges.
- 6/3 GHTA applicants will receive a notice of decision by email. The finalist will be



sent a special invitation letting them know they were selected to compete for the Governor's Cup. Serve Illinois Commission will host a press conference announcing GHTA finalist.

- 6/3-6/23 Finalists will prepare in their hometown for the GHTA finals.
- June 23, 2022 Finalist will compete for the Governor's Cup in Decatur, IL.
